Details of Petitioner and Respondents: M/s Teerth Gopicon Limited (Petitioner) And Indore Smart City Development Limited (Respondent) Brief Details of the case: The contract has been terminated by the concerned department due to non-deposit of the first instalment. However, six months' extension for the payment with penal interest was allowed in the tender and petitioner was ready to pay with applicable interest. But respondent terminated the contract without giving 30 days' notice period. The petitioner moved to the High Court of Madhya Pradesh and filed the Writ Petition. The High Court passed the order and respondent is directed to keep the amount received from the petitioner in an interest-bearing account and the same shall be subject to final outcome.
